The Association is a Texas non-profit corporation, and attached to this certificate is a true and correct copy of the Certificate of Formation of Bellago Community Improvement Association.



Article 5 - Purpose

The corporation is organized for the following purpose or purposes:

Specifically and primarily to provide an organization consisting of the owners of that certain single family townhouse project located at Lake Conroe, Montgomery County, State of Texas, known as BELLAGO, and more particularly described in the Declaration of Covenants, Conditions and Restrictions of Bellago recorded on February 28, 2006, as Volume 2006-020550, Pages 023-11-087 through 023-11-0890 in the Official Public Records of Real Property at Montgomery County, Texas (the "Bellago Project"), to provide for the management, maintenance, preservation and architectural control of the Bellago Project.

Generally: (i) To promote the health, safety, and welfare of the owners of the Bellago Project.

- (ii) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in the Declaration and Bylaws of said Association (the "Declaration" and "Bylaws," respectively).
- (iii) To fix, levy, collect, and enforce payment of any charges or assessments as set forth in the Declaration and to pay all expenses in connection with such charges or assessments, all office expenses, and all other expenses incidental to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed against the property of the Association.
- (iv) To acquire (by gift, purchase or otherwise), own, hold, improve, build on, operate, maintain, convey, sell, lease, transfer, to dedicate for public use or otherwise to dispose of real or personal property in connection with the affairs of the Association.
- (v) To borrow money, to mortgage, to pledge, to deed in trust, or to hypothecate any or all of the Association's real or personal property as security for money borrowed or debts incurred.
- (vi) To have and to exercise any and all powers, rights and privileges that a corporation organized under the Texas Non-Profit Corporation Act by law may now or at a later time have or exercise.
- (vii) To act in the capacity of principal, agent, joint venturer, partner or otherwise.

Notwithstanding any of the above statements of purposes, the Association shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of the Association.
